Dear Representatives Trone, Takano, and Levin:

On behalf of the associations listed below, representing two- and four-year, public, and private colleges and universities, I write to thank you for introducing H.R. 5545, the Responsible Education Mitigating Options and Technical Extensions (REMOTE) Act. We strongly support this legislation, which includes important provisions to help ensure veterans can continue to receive their education benefits and provides technical corrections to legislation enacted earlier this year. We stand ready to work with you and your colleagues to ensure that legislation addressing these issues is passed by Congress and enacted into law as quickly as possible.

Among its provisions, H.R. 5545 would extend certain COVID-related flexibilities granted to the secretary of the Department of Veterans Affairs (VA) in the wake of the pandemic. Without this extension, veterans could see their benefits reduced or cut off if, for example, their institution is forced to move instruction online due to the pandemic. Colleges and universities are working hard to keep campuses open for in-person learning this year, but already we have seen limited cases of campuses reverting to online instruction in response to evolving health conditions in their communities. Extending these provisions now will allow the secretary to make adjustments as needed and ensure that veterans' benefits are not disrupted.

H.R. 5545 also includes critical technical corrections to address unintended consequences stemming from the Isakson Roe Act and the THRIVE Act. Because these provisions of law took effect on August 1, it is critical that Congress move quickly to address these concerns.

We are grateful to see changes that would ensure VA's incentive compensation provision is parallel to the incentive compensation provision in the Higher Education Act, and that these provisions will be interpreted consistently. We also appreciate language allowing the secretary to waive the second certification requirement for institutions with a flat rate tuition and fee structure. These and other technical corrections address the implementation concerns raised by our colleges and universities while maintaining important protections for veterans.

While we appreciate language intended to help institutions satisfy the consumer information requirements of the Isakson Roe Act, we believe that further clarification is needed before the legislation moves forward. Specifically, we urge you to clarify that an institution “that provides to a covered individual consumer information regarding costs of the program of education (including financial aid available to such covered individual) using a form or template developed by the Secretary of Education” will have met the consumer information requirements of section 3679(f)(5) of the Isakson Roe Act. This clarification will ensure that institutions that use the Department of Education’s College Financing Plan template will have satisfied these new requirements.

Thank you for your continued work on behalf of our nation’s veterans. We greatly appreciate the work of you and your staff in assembling this important piece of legislation. We stand ready to work with you to ensure legislation addressing these issues is quickly enacted into law.
