Dear Chairs and Ranking Members of the Appropriations Committee and Subcommittees on Labor, Health and Human Services, Education, and Related Agencies:

On behalf of the organizations listed below, we write to express our strong support for the restoration of year-round Pell Grants in the Fiscal Year 2017 Labor, Health and Human Services, Education, and Related Agencies appropriations bill.

Pell Grants are the foundational undergraduate student aid program, and nearly eight million low- and middle-income students depend on Pell Grants to afford college. Currently, students who depend

on Pell must often halt their studies each summer because the aid they rely on is not available, as a result of cuts made by Congress in 2010. Year-round Pell Grants were eliminated because Congress had to address an \$11 billion shortfall in the program at the time, not because of opposition to the policy itself. Now that the program has a projected \$10.5 billion surplus in FY 17, the time is right to reinstate this provision and broaden access and opportunity for America's students.

As Speaker Ryan noted last week, the restoration of year-round Pell Grants "makes a lot of sense." Allowing all students, regardless of their credit accumulation or enrollment intensity, to access this program throughout the year reflects the reality of modern higher education. Increasingly, students are pursuing their educations year-round with the goal of entering (or re-entering) the workforce as soon as possible. Enabling low-income students this flexibility will speed their progress to a degree and enhance their economic opportunities.

As a result, year-round Pell enjoys broad bipartisan support in Congress, near-universal endorsement among policy experts, and was included in the Senate's FY17 on Labor, Health and Human Services, Education, and Related Agencies bill. With one exception, the language in the Senate bill includes key provisions that will ensure that year-round Pell Grants are responsibly awarded while also minimizing administrative burden on institutions and financial aid officers. The exception is the requirement that a student be enrolled at least half-time in the term for which the extra Pell award is sought; in many instances, the extra term is summer, when students are also ramping up their employment to earn funds for the upcoming year. For those reasons, we would urge you to incorporate the language in the Senate bill, amended to allow year-round Pell regardless of enrollment status in the extra term, as part of the restoration of this provision.

We thank you for your attention to this critical issue, and urge you to support America's students and restore year-round Pell Grants in the final FY17 appropriations.
