## **COUNCIL OF FELLOWS/FIDELITY INVESTMENTS MENTOR AWARD**

## **PURPOSE:**

The COF Mentor Award recognizes ACE member presidents' and chancellors' contributions to enhancing the diversity and capacity of future leaders of American higher education.

#### AWARD:

- An elegant memento presented to the award winner at the ACE Annual Meeting by the COF chair, a senior officer of Fidelity Investments, and the ACE president.
- A letter of recognition and appreciation for extraordinary mentoring from the Council of Fellows (COF).
- <u>Contingent on funder support</u>: A \$5,000 check towards the award winner's discretionary fund (sitting president) or to the institutional foundation of the last institution that the award winner served as president (retired president).

## **SELECTION PROCESS AND SELECTION CRITERIA:**

Nominations are solicited annually by the COF from all former Fellows. The COF Chair convenes the COF officers and committee chairs to make the selection.

To be eligible for consideration, a nominee must:

- Be a president or chancellor (or a recently retired president or chancellor) of an ACE member institution;
- Have served as mentor to three or more ACE Fellows;
- Be nominated by a former Fellow; and
- Have at least two additional supporting letters for the nomination from another Fellow mentored by the nominee.

Selection is based on the following criteria:

- Commitment to leadership development, with evidence that the nominee has aided in enhancing the diversity and capacity of American higher education;
- Intentional mentoring;
- Articulation of strategies and values that underlay decisions;
- · Evidence of transformational leadership; and
- Continuing relationships with the Fellows over time.

## **AWARD PRESENTATION:**

- The award is presented annually by the COF Chair during the ACE Annual Meeting.
- ACE will work with the winner to record their remarks that will be shared on the ACE website and ACE Engage.

- ACE will work with the award winner's institution public relations office to coordinate press releases about this honor.
- The award winner is requested to send a thank you letter to Fidelity and provide the Fellows Program with a file copy of that letter.
- The award winner will receive additional information and updates from the ACE Fellows Program office.

## **SUGGESTED TOPICS FOR ACCEPTANCE SPEECH:**

Award winners tend to have personal philosophies and heartfelt observations about their role as mentor and the meaning of mentoring to them. It is hoped that the acceptance speech will share these thoughts in a way that will inspire the audience to mentor. While the role of "mentor" in the Fellows Program specifically refers to the person at the host campus who nurtures an ACE Fellow during his or her placement, award winners tend also to have nominated many rising leaders on their own campuses to the Fellows Program and also mentored these leaders. Acceptance speech remarks may refer to both groups.

- Your mentoring role and your relationship with the ACE Fellows Program over the years.
- · Your mentees and nominees and your relationship with them during and after the Fellows Program.
- The importance of mentoring to the development of higher education leadership.
- The rewards derived from mentoring and nominating Fellows.
- A closing statement about the value of mentoring and nominating an ACE Fellow.
