# 1. About the Challenge

Thank you for your interest in the Blockchain Innovation Challenge (BIC). This document sets forth both the criteria and contents we are requiring of applications as well as the eligibility criteria, rules, and terms and conditions.

The Blockchain Innovation Challenge will make awards totaling \$900,000 to ecosystem-first designed approaches driving interoperability, social mobility and learner control. We are seeking technology-enabled solutions that reorient the education and employment ecosystem around the individuals that they aim to serve.

The Blockchain Innovation Challenge is open to teams of innovators who are seeking to positively affect and empower U.S. learners through ecosystem-first designs.

A team approach is required and should minimally demonstrate a collaboration of education stakeholders (post-secondary and/or K-12) and technology providers. Additionally, we encourage applicants to consider engaging employers, community-based organizations, student groups and any other organization that is critical to the ecosystem.

This challenge invites teams to articulate a vision and design pilots that address the following themes:

# Empower all learners

• How can learners exercise agency over their digital identities, including all records of learning, so they can share them in a secure, validated, and machine-readable way?

## Unlock lifelong learning

O How can learning be better documented, validated, and shared no matter where it occurs? How can control or ownership of learning records improve the way underserved learners connect and unlock disparate learning opportunities?

# Improve economic mobility

• How can blockchain support learners to find in-demand education in employment-relevant skills to advance economic mobility and to fulfill the promise of higher education?

We have identified three key opportunity areas that teams must address since they are important characteristics of an ecosystem-first design approach. It is strongly recommended that you read the report; Connected Impact: Unlocking Education and Workforce Opportunity Through Blockchain (https://www.acenet.edu/Documents/ACE-Education-Blockchain-Initiative-Connected-Impact-June2020.pdf), to see how these three key opportunity areas can meet the Challenge's goal of enabling individuals to achieve social and economic mobility.

### • Building community and consensus

 Networks of institutions and organizations are important precursors to many blockchain initiatives in education. By cultivating these communities to solve a common challenge, and then engineering the blockchain solution as the connective tissue to pull existing components of the ecosystem together and reorient around the needs of learners.

# Interoperability and open design

Solutions that leverage open data standards and protocols are critical to the mobility of individuals between the
multiple learning and employment domains in their lifetime. Interoperability is such a critical component of
this Challenge that the Department of Education commissioned a whitepaper to provide a standards guide
(https://docs.google.com/document/d/1emJ7YMmkbs1QlIRojVyJ4urA0VuUD Z-3domGHXwmYE/edit).

# Data literacy and agency

O Distributed ledger technology holds the potential to provide individuals with immediate access to their digital data, the ability to control who can view it, and a way for their data to be verified without contacting the issuing parties--allowing individuals to traverse seamlessly along a lifelong pathway of learning and work. Applicants should address how they can counter the digital skills and data literacy divide, which holds potential to compound disparities for traditionally underserved populations.

### **Prizes**

The Blockchain Innovation Challenge will be conducted in two phases. Winning teams will share up to \$900,000 in prize money. Up to four phase 1 winners will be awarded up to \$150,000 each. Teams that demonstrate interoperability of their Minimum Viable Product (MVP) as an output of Phase 1 will receive Phase two funding for full implementation of the pilot. Up to four Phase 2 winners share the remaining prize balance.

## In addition, winners will receive:

- National recognition through a variety of channels;
- Leadership opportunities in community engagement to share lessons learned and best practices;
- Be featured in ACE communications about the Education Blockchain Initiative;
- Play a key role in working with ACE and other stakeholders to develop potential governance standards;
- Mentorship from leading technology firms; and
- Additional opportunities and awards may be announced.

### **Evaluation Criteria**

Applications will be evaluated on the following criteria:

- Quality of the Ecosystem-First Design Approach
  - Defines the problem and appropriate solutions that demonstrate potential for impact during and beyond the project window
  - o Documents a comprehensive ecosystem that identifies the needs of appropriate partners, stakeholders, learners
  - o Depicts the flow of data across ecosystem
  - o Empowers learners
  - o Promotes social mobility
- Quality of the Technological Approach
  - Clearly describes an execution strategy for the duration of the Challenge window that includes a short-term plan to demonstrate their MVP by the end of Phase 1
  - o Stipulates technical capacity that meets objectives
  - Specifies conformance with open standards and interoperability
  - o Clarifies data security and privacy in the compliance with federal and other regulations
  - Validates learner control of identity
- Quality of the Management Plan and Adequacy of Resources
  - o Outlines team qualifications
  - o Describes budget
  - o Demonstrates a post-challenge business plan and sustainability

# Submission Process and Formatting Requirements

- Applications must be submitted through the ACE Blockchain Innovation Challenge portal site (http://www.acenet.edu/bic) as a PDF document.
  - Only submissions received through the ACE portal site will be reviewed for consideration.

• To ensure equity for all applicants, proposals must adhere to the page, font size and format specifications (including citation footnotes). Proposals that do not adhere to the specifications below will not be accepted.

# o Length Requirements:

- Length Applications may not exceed 15 pages.
- Applications must include a 300-word short form summary of the initiative that concisely describes and summarizes the project and its objectives. Nothing in the short form summary should be proprietary or confidential, and the short form summary may be used for BIC press releases and other BIC communication collateral.
- Applications may include an appendix (maximum 5 pages that does not count towards the 15-page limit) with resumes, bios for key team members, and summaries of other relevant projects to demonstrate expertise.

# o Formatting Requirements

- Pages For the purposes of applications for the Blockchain Innovation Challenge a "page" is 8.5 inches x 11 inches, with 1-inch margins at the top, bottom, and both sides.
- Spacing At a minimum single space all text in the proposal, including titles, headings, footnotes, quotations, references, and captions, as well as all text in charts, tables, figures, and graphs.
- Font Proposals must be submitted using the Calibri regular font type with no letters being smaller than 12-point font size in Microsoft Word.

# 2. Rules and Eligibility

- Subject to the foregoing restrictions, any individual or group of individuals that have the ability and capacity to respond to the objectives of this Challenge may apply to participate in the Education Blockchain Innovation Challenge (hereinafter, "Applicant");
- Any Applicant must be a person of at least 18 years of age and a citizen or permanent resident of the United States (defined as The 50 States of the United States, the District of Columbia, the Commonwealth of Puerto Rico, and the outlying areas of the United States Virgin Islands, Guam, American Samoa, the Commonwealth of the Northern Mariana Islands, and the Republic of Palau) ("Individual Applicant") or
- An entity registered or incorporated in accordance with applicable State and local laws, and maintaining a primary place
  of business in the United States ("Organizational Applicant"). These include, but are not limited to, nonprofit and forprofit organizations, institutions of higher education, such as colleges and universities, and elementary and secondary
  schools.
- The Organizational Applicant may include foreign citizens participating as [owners or] employees.
- Teaming. Applicants may work in conjunction on any Education Blockchain Innovation Challenge application ("Teams"). Teams must have at least one Individual Applicant or Organizational Applicant that meets the eligibility criteria set forth above. For the avoidance of doubt, Teams may include foreign citizens who are not permanent residents;
- Institutions of Higher Education applying as the main Applicant, or as part of a team, must be
  - o licensed in the state in which it is physically located and any other state for which licensing is required and
  - o in material compliance with any applicable accreditation standards, and applicable state and federal laws.

- Elementary and Secondary Schools applying as a main Applicant, or as part of a team, must be in material compliance with applicable state and federal laws or applicable accreditation standards.
- Ineligible Applicants include:
  - o A foreign citizen unless participating as part of an eligible team or entity;
  - A Federal entity;
  - o A Federal employee acting within the scope of his or her employment; and
  - All employees of ED, ACE, ACE's Challenge partners, Steering Committee members and their employers/employees, and/or any other individual or entity associated with the development or administration of the Challenge, as well as members of such persons' immediate families (spouses, children, siblings, parents), and persons living in the same household as such persons, whether or not related.
- Applications must be submitted by October 30, 2020. Individual extensions to the due date will not be granted.
- Applications must be submitted on the ACE EBI Submission Page and must adhere to the submission requirements set forth in the Challenge.
- Any application that is late or is not submitted as a PDF that complies with ACE guidelines will not be given consideration.
- Applicants selected to receive a grant may not use any funds received from ACE for any activities that are not expressly part of fulfilling their responsibilities as a Challenge pilot.
- As a condition of participation, each selected EBI Challenge site must;
  - Assume any and all risks and waive claims against the Federal government and its related entities, except in the case of willful misconduct, for any injury, death, damage, or loss of property, revenue, or profits, whether direct, indirect, or consequential, arising from their participation in the Challenge, whether the injury, death, damage, or loss of property, revenue, or profits, whether direct, indirect, or consequential, arises through negligence or otherwise;
  - Agree to indemnify ACE and its EBI partners against third-party claims for any damages arising from or related to competition activities.

- By submitting an application, applicants agree to hold ACE and its EBI partners harmless from all legal and administrative claims to include associated expenses that may arise from any claims related to their entry or participation in the Challenge.
- Applicants are not required to obtain liability insurance or demonstrate financial responsibility in order to participate in the Challenge.

# 3. Legal Information

INTELLECTUAL PROPERTY (IP)/REPRESENTATIONS AND WARRANTIES/INDEMNIFICATION

Applicants retain ownership and all rights to the submission and any invention or work, including any software, research or other IP, submitted as part of the submission or developed in connection therewith.

By participating in the Education Blockchain Innovation Challenge, each Applicant (and on behalf of each member of an Applicant's Team) certifies, represents, warrants, and covenants to ACE and ED the following:

- Neither Applicant's response to an RFP nor ACE's or ED's use of information contained in a response will constitute an infringement or violation of the intellectual property rights (including but not limited to trademarks, copyrights, patents, trade secrets, moral rights) or privacy rights of any person or entity.
- The Applicant is the sole author, creator, and owner of the submission and/or has secured all necessary licenses and/or rights necessary to assure that the submission does not, and will not, violate or infringe upon the intellectual property rights, privacy rights, publicity rights, or other legal rights of any third party; and that
  - The submission; does not, and will not, contain any harmful computer code (sometimes referred to as "malware," "viruses," or "worms");
  - The submission, and Applicant's use of the submission, does not, and will not, violate any applicable laws or regulations of the United States.
- If the submission includes the work of any third party, the Applicant will provide, upon the request of ACE, documentation of all necessary and appropriate licenses or other indicia of right of the Applicant to include such third-party works. If the Applicant cannot provide such documentation, ACE reserves the right, in its sole discretion, to disqualify the applicable submission. In addition, ACE reserves all rights to pursue an Applicant for claims based on damages incurred by the Applicant's failure to obtain such licenses and releases.

- The submission is not the subject of any actual or threatened litigation or claim.
- Neither Applicant nor any organizations in which Applicant is employed or serves as directors have been debarred, suspended, or terminated from participation in any program administered by ED.
- Neither Applicant nor any organizations in which Applicant is employed or serve as directors has been convicted of, or has pled nolo contendere or guilty to, a crime involving the acquisition, use, or expenditure of Federal, State, or local government funds, or has been administratively or judicially determined to have committed fraud or any other material violation of law involving Federal, State, or local government funds.

### SUBMISSION LICENSE

Each Applicant retains title to, and full ownership of, its submission. The Applicant expressly reserves all intellectual property rights not expressly granted under this agreement. By participating in the Blockchain Innovation Challenge, each Applicant hereby irrevocably grants a license to ACE and ED to store and access submissions in perpetuity that may be reproduced or distributed in the future.

### PUBLICITY RELEASE

By participating in the Blockchain Innovation Challenge, each Applicant hereby irrevocably grants to ACE, ED, and their Challenge partners the right to use such Applicant's name, likeness, image, and biographical information in any and all media for advertising and promotional purposes relating to the Blockchain Innovation Challenge, and otherwise, as stated above in "Submission License".
